# How to use

- The surface has to be clean, dry and free from fat.
- Before painting plastic parts, use DUPLI-COLOR Plastic Primer.
- Mask off surfaces not to be painted.
- · Before use, shake can for 3 minutes.
- Test colour of spray and compatibility at an invisibible spot.
- Apply from a distance of approx. 25 cm several thin cross-coats.
